**YAYASAN MENDAKI's 29TH AGM
SCHOOL READY: PERFORM IN SCHOOL: FUTURE READY**

Yayasan MENDAKI held its 29th Annual General Meeting (AGM) at Wisma MENDAKI today. It was chaired by Mr Masagos Zulkifli Bin Masagos Mohamad, Minister for the Environment and Water Resources, Minister-In-Charge of Muslim Affairs and Chairman of MENDAKI's Board of Directors.

The AGM received and adopted the Directors' Reports and Accounts for the year ended 31 December 2017. MENDAKI reported an expenditure of \$33 million to support the community's development through education and impacting more than 71,000 beneficiaries.
